The MIL Skills project is here to bridge that gap, targeting seniors aged 55+ and adult educators, with tools, training, and resources designed to build confidence, critical thinking, and safety online.

The MIL Skills Training Programme

This comprehensive training programme focuses on equipping older adults and their trainers with core competencies in media and information literacy. Delivered through a blended learning model, combining in-person workshops with interactive online modules, the programme enables participants to:

- Assess and critically evaluate digital content.
- Protect their data and privacy online.
- Communicate responsibly on digital platforms.
- Understand their digital rights and responsibilities.

MIL Skills Digital Board Game

Learning can be fun! Work Package 4 introduces the MIL Skills Digital Board Game, an engaging, turn-based educational game modeled after “trivial pursuit.”

The game is:

- Tailored for seniors 55+
- Playable in English and six national languages
- Designed for up to six players in a 30-minute session
- Full of thought-provoking questions and choices based on MIL topics

The MIL Skills Toolkit

Work package 5 is coming soon and it will deliver a comprehensive Toolkit designed for:

- Adult trainers
- Organizations and institutions involved in adult education
- Policy experts and stakeholders

The Toolkit will include lesson plans, adaptable resources, and classroom tools to help integrate MIL concepts into training environments. It will also provide guidance on combating misinformation and supporting digital inclusion in adult learning contexts.

WP5 also features national awareness campaigns through multiplier events, where results will be showcased, and valuable feedback will be gathered to further refine and expand the project’s impact.



Pilot Testing: Learning in Action

To ensure that all project tools and materials meet the needs of the target groups, MIL Skills is currently conducting pilot testing across all partner countries.

Each organisation will engage at least 25 seniors (aged 55+) and 10 adult educators.

That's a total of 200 seniors and 80 trainers across Europe who will test the training modules, play the board game, and provide feedback on usability, accessibility, and effectiveness. This process is crucial for shaping the final versions of the learning tools and ensuring they meet real-world needs.
